

ORDER ON AGREED MOTION OF THE REHABILITATOR OF STANDARD LIFE INSURANCE COMPANY OF INDIANA TO EXTEND MORATORIUM AND FILING DATE

This matter comes before the Court on the Agreed Motion of the Rehabilitator of Standard Life Insurance Company of Indiana to Extend Moratorium and Filing Date, filed by the Insurance Commissioner of the State of Indiana, in her role as Court appointed Rehabilitator of Standard Life Insurance Company of Indiana. The Court, having reviewed and considered said Motion, and being duly advised in all things, now grants said Motion. It is hereby Ordered, Adjudged, and Decreed that the moratorium on loan and cash surrender rights of all Standard Life policies and certificates of insurance is extended from March 31, 2010, to and including the later of six months after the closing of a transaction to transfer the annuity liabilities of Standard Life to an assuming carrier or purchaser, or three months from the date of an order of liquidation entered by this Court that does not include such a transaction, such extension to be continuous

from March 31, 2010; and that the filing date for a final receivership plan is extended to and including June 30, 2010
